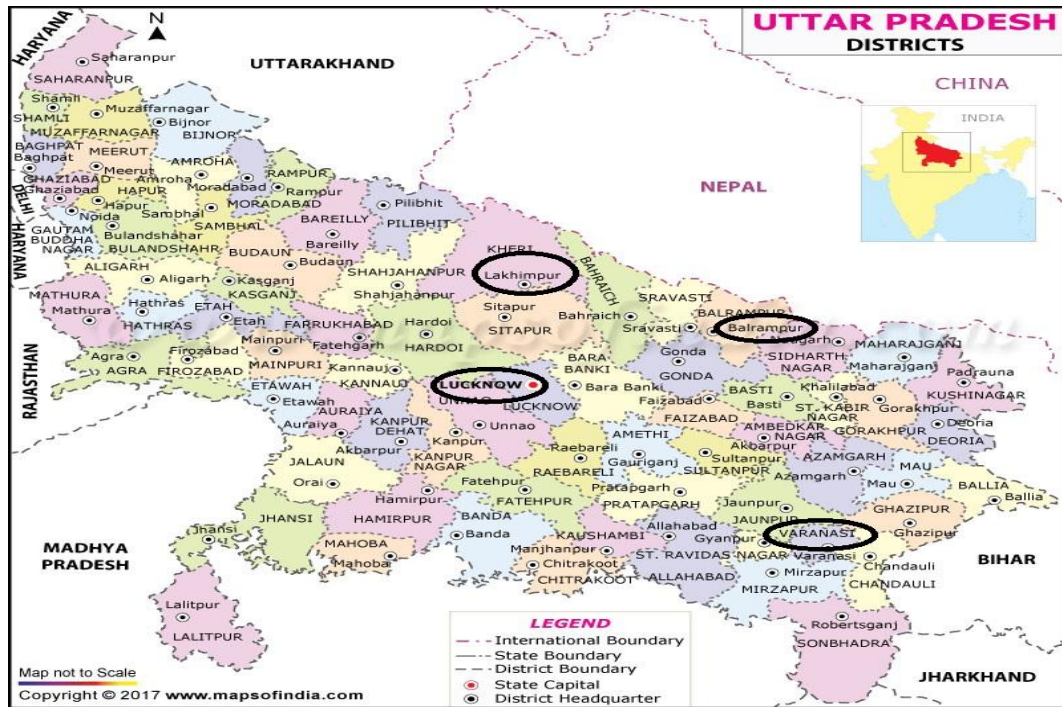

## Reports at a glance 2017-2018

### Resilient Agriculture in Lakhimpur Kheri



*Aim works with small, marginalized women farmers in 25 villages of Block Mitauli, District Kheri to increase their income and improved their livelihood by adopting different climate resilient agriculture practices in agricultural field.*

#### Programme Activities-

##### **Mobilization drive in 25 villages in support to increased MSP**

Aim organized a five days awareness campaign to increase and implementation of Minimum Support Price (MSP) in favor of women and marginalized farmers for the crops of paddy/wheat and sugarcane in September 2017 in 25 villages of Block Mitauli, District Lakhimpur Kheri. The women farmers and volunteers of Aim visit door to door in villages and organized meeting in each village with women farmers to sensitize them on MSP.

During the campaign, the women farmers raised their problems and issues related to MSP of paddy,

wheat and sugarcane. A demand letter is also prepared to increase MSP of crops. Women farmers actively participate in the campaign and also do signature on banner during the campaign. The volunteers also give pamphlets (relating MSP) to the women farmers.

### **Mahila Kisaan Mahasamellan**

Aim organized a block level Mahasammelan for women farmers in the month of December 2017 with the support of Oxfam India at Ratehra, Kasta, Lakhimpur Kheri. The main chief guest of this meeting was Mr. Ajay Kumar Singh, DDM NABARD; Dr. Mohd. Sohail and Dr. Pradeep Kumar Bisen, Agricultural Scientist Lakhimpur, Dr. Ram Lochan, ex agricultural scientist, Mr. H.U Siddiqui, Integrated Pest Management, Lucknow; Mr. Ram Bahadur, Ex Assistant Development Officer Agriculture, Pasgawan, Kheri the volunteers of Aim. 250 women farmers were presented during the programme.

During the consultation, best practices adopted by women farmers, success stories and challenges shared by women farmers. Women farmers honored by giving a plant of Guava at the end of the program.

He advised women farmers to use tricho card for control pest, to give water in crops by leave one line in field and he also advised to protect the crop from frost by smoke , do soil testing and also to use Super Phosphate manure in agriculture field for hard soil.

## Child Rights

### School Chalo Abhiyaan

Aim organized a School Chalo Abhiyan campaign in Block Mitauli District Kheri in the month of July, 2017 with the support of Vigyan Foundation and Behtar Shiksha Haq Abhiyaan. The campaign was organized in closed collaboration with school teachers and children who were intensively involved to ensure 100 percent enrollment. The main objective of this campaign was to send all children in school and aware parents to send their children in the school. Many slogans and songs related to enrolment were raised

### International Day for Girl Child Celebration

Aim organized a campaign in Lucknow, Uttar Pradesh on the occasion of International Day of the Girl Child on 11<sup>th</sup> October, 2017 under Muskaan Project with joint collaboration of Actionaid partners. The objective of this campaign was to spread awareness on safety of girl child, increasing their enrollment and attendance. Apart from this, the campaign also focuses on various issues such as gender inequality, child marriage, menstrual health management etc. Nearly 48 villages covered in the awareness campaign and total 1200 participants (998 female and 202 male) participated. The participants were the members of SMC, PRI, teachers, government officials, children and local community.

## Digital Literacy

### Internet Saathi Programme

The Internet Saathi programme, a digital initiative programme is being implemented by Aim Trust in partnership with Tata Trusts, Google India, Phia Foundation in 15 districts of Lakhimpur Kheri, Uttar Pradesh. The programme aims to increase the access and control over digital resources, helps women to explore various uses and benefits of the internet, generate awareness about several internet based information/schemes provided by government and facilitate use of the internet by women in accessing such schemes provided by the government.

## Case Study

### Now my son goes to school regularly...

Suman devi (35 years); lived in Bhagwant Nagar village Block Mitauli, District Lakhimpur Kheri. Her husband name is Manoj Kumar (39) and she has one son who studies in Class 7. His school is 12 km far away from his village. So, he does not attend school regularly. Sometimes he goes to school with his friends on bicycle.

There is a group of farmers of 15 women in a village, Bhagwant Nagar who are being facilitated by the Aim Trust supported by Oxfam India. The members of this group named as "Muskaan Mahila Kisan Samuh. This group was formed two years ago. This group regularly attends the meeting organized by Aim and learns different Climate Resilient Practices and also adopt in their fields. The women farmers of this group collectively learn to produce Mushroom farming.

Suman Devi, one of the active members of the group. She with 15 women members of her group started to save monthly saving and deposit Rs. 40 per month. With the support of Aim, her group Muskan Mahila Kisan Samuh opens account in the Allahabad bank, Kasta, Mitauli. One day, the volunteer of Aim told about the scheme of National Rural Livelihood Mission for women Self Help Group. After this with support of Aim, her group linked with National Rural Livelihood Mission (NRLM). Under this, the women group gets the work of sewing school dress of children. The group actively made the dress and give on right time to school. Before, the children could not get dress of their size but this time they get dress according to size. After that, NRLM give Rs. 15000 to group as the corpus amount for the revolving fund. Her group members get Rs. 1000 each and they started using money in agricultural needs.

Suman Devi also get Rs. 1000 from her group. Before she saved Rs. 2000 and after getting Rs. 1000 she buy a new bicycle for her son of Rs. 3100. Her son is very happy and starts to go to school regularly with his new bicycle. She is also doing mulching and inter cropping of garlic with gram in her agriculture field for getting good production of crop .

This year the women farmers of this group do cultivation of paddy by SRI method, inter cropping of garlic and gram, mulching and also make compost, vermi wash and use in their fields.

### **Collective Story of Success of Girls Education in Utraula, Block, Balrampur, U.P.**

A society without education is a society without spirit. In primary school of Baksariya village of Utraula block, it was found that the children were used to clean school premises every day after reaching school. As a result, attendance ratio of the Baksariya primary school decreased day-by-day. Aim staff talked to the teachers, community and School Management Committee (SMC) members about this practice and called a community meeting. It was found that members of the SMC were not aware about their roles and they have the assumption that they are only responsible to sign the cheques as per need.

They felt happy that this was the first time they sat together and came to know about their roles along with their importance for the betterment of educational status of their village. Parents were bound to send their kids nearby private school rather than government schools. In the community meeting Gram Pradhan (Village Head) also invited to seek his support. After conducting several meetings with SMC, teachers and parents the success was finally achieved. Gram Pradhan took the initiative and called the sweeper and asked him to clean school premises on regular basis.

Now children are also happy and they attend school regularly. Parents are also happy in sending their children to the Baksariya primary school. It's a group initiative which brought radical changes in the school and helped children in regular attendance.
